

## PRIVACY POLICY OF TMS-FOOTBALLSHOP-BERLIN / JUMPJUMPBOSSCHEERCORNER

TMS-Footballshop-Berlin / JumpJumpBossCheerCroner subsequently called „TMS“.

### 1. TMS about privacy

The protections of personal datas are very important for us. Therefore we conduct our activities in accordance with the legislation for the protection of personal datas and the security. Following we inform you about the information, which we will collect, how we will use it and whom we will make it available if it is necessary.

### 2. Personal datas

With our website, we don't receive any personal datas (for example: names, addresses, telephone numbers, or email addresses) only you inform us about it (for example: registration, survey) or rather you confirmed us about the security your datas.

### 3. Purpose

The personal datas, which we received from your side, in general we will use it for answering your enquiry, to work on your order, to gain access for information's or offers. To care the relation with a client is it necessary for,

- that we safe your personal datas for respond to your wishes in a better way or improve our services and products or
- to inform you about offers from TMS or for a online survey, to be satisfactory for tasks an requirement of our clients.

Of course we respect it, if your not agree to use your personal datas for a relation with a client (direct marketing, market research). We didn't sale your personal datas to third part or we don't market otherwise. Our workers, companies and dealer are committed of our confidentiality.

### 4. Purpose limitation

TMS will use, rise and handle your personal datas (about what the client informed us) only for purpose what we wrote before. Except if the rise, handle ore use

- for another purposes, which is directly related to the original purpose, for which personal datas are collected,
- for preparation, negotiation and impregnation of contracts,

- because of legal obligations or administrative or judicial order,
- in support or for protection of legal claims or for defensive of complains,
- to prevent of abuse or other illegal activities, for example intentionally attacked to TMS systems for warranty of the data security.

### 5. Communication- or utilization details

If you access our website about a telecommunication, we will receive information like communication details (for example: internet-protocol-address) or utilization details (for example: information about use commencing and useful life and also information about your telecommunication) automatically. This allows conclusions of personal datas. If is necessary subject the collection, processing and application of your communication- and utilization details the statutory regulation.

### 6. Automatically register of non-personal datas

If you access our website, we will receive information automatically (without registration). For example internet-browser and operating system; domain-name of website, numbers of visits, average times, called pages, which is attributable to any person. We will use this kind of information's to improve our website.

### 7. „Cookies“ – information's, which are stored automatically on your computer

If you visit ones of our website, it could be, that you receive information in the form of a "cookie" on your computer. Cookies are little datas, which are stored on your HDD temporarily. Cookies allows us for example to adapt a website to your interests or to safe your password, so you don't have to be login every time. A cookie helps us to identify popular areas of our internet offer. So we can tune our website to your need. Cookies can be used to determine, if your computer communicated already to our website. Cookies makes possible to identify your computer, but not he personal information's. You can delete the cookie-application, if you setting the internet-browser, that the HDD delete, blocked or warn all of the cookies.

### 8. Security

TMS hits technical an organizational security measures, to protect your personal datas for deletion, variation or loss and against of unauthorized dissemination or unauthorized access.

#### **9. Links to other websites**

The TMS-website could be have links of other websites, to which the disclaimer does not cover. TMS is not responsible for the privacy policy or the contents of the other websites.

#### **10. Minors are allowed to use the TMS-online shop?**

TMS don't offer products for minors. Only the parents are allowed to buy products for teenies. If they don't reached the 18's year, they are only allowed to use the TMS-online shop with their parents or a guardianship.

#### **11. Right of information**

On requirement we inform you about your person datas, which we safe in our computer. Are you registered, so you have the possibility to see your personal datas and you can delete or change information's about you, whenever you want. Should we have wrong information's, we will correct it with your call immediately.
